



PEECA SAVE UP Programme Guidelines for Air Conditioner Model Registration

How to register your Air Conditioner (AC) Model

Check List to Start Registration:

Before filling out the **SAVE UP** AC model registration application, ensure you have the following items ready:

1. Supplier Registered Certificate C-1:

This is issued by PEECA upon supplier registration and is unique to each supplier. It is required for the registration of air conditioner models under the SAVE UP programme.

2. Product Specification Data Sheet:

The Product Specification Data Sheet provides detailed information about the model you are registering. This document is crucial to understand the technical aspects and characteristics of the air conditioner model.

The data sheet typically includes, but is not limited to: technical specifications, e.g. dimensions, power ratings, efficiency metrics, material composition and construction details.

3. Test Report:

To complete the registration process, a test report for each air conditioner model (or family) must be attached. A valid test report can be sourced from in-house laboratories, government-owned facilities or private labs and must have been conducted within the 6 months prior to the date of this registration. The reference test standards for these laboratory tests are included in the Partner Agreement for Air Conditioners.

Registration Process Steps:

1. Visit PEECA's website at www.peeca.punjab.gov.pk.
2. Click on the "SAVE UP" tab.
3. Download the "SAVE UP Air Conditioner Model Registration Application."
4. Open the "SAVE UP Air Conditioner Model Registration Application" and fill it out as explained below.
5. Attach the relevant documents.
6. Email the completed form.
7. Upon successful registration, you will receive **Certificate C-2** with a unique **AC Model Registration No.** issued by **PEECA**.





How to fill the SAVE UP Air Conditioner Model Registration Application:

Open the SAVE UP Air Conditioner Model Registration Application.

1. General Product Details:

- Enter the PEECA's **Unique Supplier Registration No.**
- Enter the **Brand Name**.
- To register a single model, select *Single*; to register a family of models, select *Family*.
- Enter the **Model Name(s)** covered by this application.

The following detail will be found in **Product Specification Data Sheet**.

- Select the **Rated Voltage (V)**.
- Enter the **Rated cooling capacity (kW)**.
- Select the **Refrigerant type used in this AC model**.

3. Test Details:

The following detail will be found in attached **Test Report**.

- Select the option of **Test Method** used to conduct the test.
- Select the **Test Laboratory Type**.
- Enter the **Test Laboratory Name**.
- Enter the **Test Report Number**.
- Enter the **Test report date**.

- Enter the **Rated cooling seasonal performance factor (CSPF)**.

- Enter the **Name of Applicant**.
- Enter the **Signature of Applicant**.
- Enter the application submission date.
- Check the box to confirm which documents you have attached.
- Save the completed form and email it with the attachments indicated above.
